Bank smarter

Don't spend more than you have to on bank charges. Here are a few tips on managing your bank account more cost-effectively.

- Make sure you have chosen the right account to suit your banking behaviour.
- Pay for goods with your debit or cheque card and avoid the cost and risk of withdrawing cash.
- If you have to draw cash:
 - draw one larger amount less often, as this will save the cost of numerous withdrawal fees;
 - use Nedbank ATMs to save you time and money rather than drawing inside a branch;
 - avoid using the ATMs of other banks, which charge a Saswitch convenience fee; and
 - withdraw cash at any participating retailer tillpoints such as Pick n Pay or wherever you see the Nedbank mini-ATM sign.
- Receive payments electronically – you'll avoid the cost of depositing cash, as all electronic and cheque payments into your account are free.
- Register for self-service banking and avoid the cost of going into the branch. Bank via a range of convenient channels – SSTs at branches, a telephone, a cellphone and the internet. This will allow you to:
 - make balance and statement enquiries for free; and
 - transfer funds between your accounts and pay bills at a much lower cost than paying by cash or writing out a cheque.
- Apply for a higher overdraft limit if your current limit is insufficient.
- If you do not require your whole overdraft limit, ask your banker to reduce it and you will pay a lower facility fee.
- Keep a good credit record by always making your payments on time.
- Avoid unnecessary rejection or dishonouring fees by staying within your credit balance or overdraft limit.

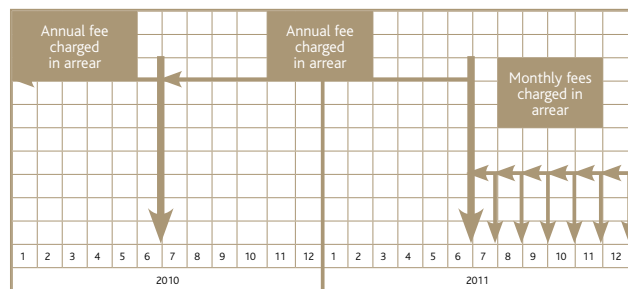
