Now you can transfer funds from call accounts to current accounts, as well as to accounts held at other banks. It also allows you to issue instructions such as giving notice on call accounts, or managing your mature investments.

## Frequently asked questions

#### Q: What does NedTreasury cost?


**A:** There is no monthly subscription fee. Normal transactional fees apply. Tokens are charged at R1 400 each if you do not have a Nedbank token.

#### Q: Do NedTreasury's access rights cater for the segregation of functions?

**A:** The company's delegated authorisers can allocate specific access rights to each NedTreasury user. These rights may include the right to deal in specific products, and they are maintained through the 'Profile information' function of NedTreasury.

#### Q: Is NedTreasury a secure environment?

**A:** Yes, NedTreasury uses advanced security-token technology, which comes with a user certificate and is protected by a token PIN and password. Duties of NedTreasury users may also be segregated, and this segregation is completely under the control of the company. Each transaction type can be set up with multiple authorisers.
