

Terms and conditions

1 THE COMPETITION

2 COMPETITION PERIOD

The competition starts on 1 April 2021 and ends 30 April 2021.

3 WHO CAN AND CANNOT ENTER THE COMPETITION

3.1 To enter the competition, participants (you) must:

- 3.1.1 be a Nedbank Retail client;
- 3.1.2 be 18 years or older; and
- 3.1.3 have a valid Hollywoodbets account.
