#### **Promoter**

- 1 Nedbank Limited (**we, us, our**) promotes this competition.

#### **Competition period**

- 2 The competition starts on 27th September and ends on 30 November 2021 (**competition period**).

#### **3 Who may enter the competition**

- 3.1 To enter the competition, qualifying participants (**you, your**) must:
- 3.1.1 be a South African small-business owner
  - 3.1.2 be 18 years and older;
  - 3.1.3 have a valid South African identity card, document (green identity book) or passport.

#### **4 Who may not enter the competition**

- 4.1 The following persons may not enter the competition:
- 4.1.1 our directors, members and employees or their spouses, life partners, business partners or immediate family; and
  - 4.1.2 our agents, consultants, and marketing service providers.

#### **5 Details of the competition and how to enter**

- 5.1 You stand a chance to win one of 20 cash prizes to the value of R50 000,00 each.
- 5.2 To enter this competition, you must:
- 5.2.1 open and meet all the product requirements of one of the following business accounts Startup Bundle Account; Business Pay-as-you-use account or Business Enabler Account (SBS Accounts) between 27 September and 30 November 2021;
  - 5.2.2 ensure that your SBS Account is active and used for business purposes, and has a credit balance of at least R100,00
