

## TERMS AND CONDITIONS

### Win fuel for a year to the value of R20 000 with Nedbank Greenbacks and bp

#### 1 The promoter

Nedbank Limited, registration number 1951/000009/06 (**we, us, our**), runs this competition and we reserve the right to make it available to our clients.

#### 2 Competition period

The competition starts on 1 June and ends on 30 November 2022 (**competition period**).

#### 3 Who can and who cannot participate in the competition

3.1 A participant (**you, your**) must:

3.1.1 be natural person of 18 years or older;

3.1.2 reside in South Africa and have a valid South African identity document or card;

3.1.3 be a Nedbank Greenbacks member and must be on the Greenbacks Card Swiper package; and

3.1.4 have their bank account be in good standing, which means that it must not be in arrears or handed over for legal collection.

3.2 Our employees (including temporary and contract employees), associated companies, agents, contractors and sponsors may not participate.

#### 4 The prize

Each month during the competition period, one participant will win R20 000 in bp fuel vouchers.

#### 5 How to enter

5.1 To stand a chance to win the prize, you must meet the requirements in clause 3 and clause 5.2 during the competition period.

5.2 You must:

5.2.1 fill up at bp petrol stations in South Africa every month during the competition period; and

5.2.2 pay with your Greenbacks-linked Nedbank credit or debit card.

#### 6 Selection of the winners

- 6.3.4 We will deliver the prize to the delivery address agreed with you and you agree that we may share your delivery details with our delivery agent.
